

**YADKIN VALLEY PUMPKIN FESTIVAL
RULES & REGULATIONS
September 27, 2008**

Please read carefully! These rules and regulations are part of the Festival contract and each participant should read, *sign* and adhere to these rules as listed below.

1. Booths will be assigned by the Festival Steering Committee on a first-come first-serve basis. Priority will be given to those who have participated in previous Festivals or those with special needs.
2. All products, crafts & works entered must be for available sale.
3. Each vendor is responsible for collecting applicable sales tax.
4. All vendor space sold in 10' increments by 10' depth. I.e. 10x10, 10x20
5. Booth vendors must supply own tent, tables, chairs, display racks, all weather gear and the like.
6. The Festival will be held rain or shine.
7. The booth fee is only refundable if the Steering Committee should judge your application not acceptable.
8. Craft booths must be original work: Staffed only the dealer, no agents. Only hand-crafted works may be entered.
9. Commercial Vendors may offer mass produced items ~ booth location will be determined by the committee.
10. The Festival Steering Committee shall have sole discretion to require the removal of work or entire booths that violate any Festival rules. The Festival Steering Committee reserves the right to approve or reject any application for any reason.
11. The Festival and its sponsors are not liable for injury or theft occurring during the event.
12. For publicity and assistance in judging booths, a picture of your work, booth, and a brief biographical statement must be included with your application. Incomplete applications may not be considered for approval.
13. **NO PETS ALLOWED !!!**
14. No Electricity will be available.
15. **MUST BE SET UP BY 8:00AM. NO VECHILES WILL BE ALLOWED ON THE STREET AFTER 8:00AM.**

SET UP TIME: Saturday, September 27 ~ 6:30 to 8:00 A.M.

Festival Hours ~ 8:30 A.M. to 5:00 P.M.
