RULES & REGULATIONS
FOOD VENDORS
SEPTMEBER 27, 2008

Please read carefully! These rules and regulations are part of the Festival contract and each participant should read, *sign* and adhere to these rules as listed below.

1. Booths will be assigned by the Festival Steering Committee on a first-come first-serve basis. Priority will be given to those who have participated in previous Festivals or those with special needs.
2. Each vendor is responsible for collection of applicable tax.
3. All food vendor space sold in 13'x10' increments. *Cart tongues, tent stakes or guide wires, or awnings hang over the 10' x 13' foot area assigned, you will be asked to buy an additional space.*
4. Booth vendors must supply own tents, tables, chairs, display racks, power cord, all weather gear and *FIRE EXTINGUISERS*.
5. The Festival will be held rain or shine.
6. The booth fee is only refundable if the Steering Committee should judge your application not acceptable.
7. The theme of the Festival is fall harvest, and booths should be in keeping with this atmosphere.
8. All vendors must name Yadkin Valley Pumpkin Festival on a certificate of Insurance for the event. Please contact your insurance carrier for details.
9. The Festival Steering Committee shall have sole discretion to require the removal of work or entire booths that violate any Festival rules. The Festival Steering Committee reserves the right to approve or reject any application for any reason.
10. The Festival and its sponsors are not liable for injury or theft occurring during the event.
11. Food Vendors can not sell cold drinks.
12. NO PETS
13. No vehicles will be allowed on the street after 8AM.

Festival Hours ~ 8:30 A.M. to 5:00 P.M.
